# GCA Rules

---

1. Please carefully read and follow GCA Flower Show Rules, General Information and Division Guidelines. All rules as stated in *The Garden Club of America Flower Show and Judging Guide*, July 2014 Edition, shall apply.
2. All plant material must be correctly identified with the botanical and common names, if possible. Accepted references for nomenclature are:
  - AHS A-Z Encyclopedia of Garden Plants
  - The Plant List at <http://www.theplantlist.org>
  - International Plant Names Index: [www.ipni.org](http://www.ipni.org)<http://www.internationalplantnames.com>
  - Plant Systematics: <http://www.plantsystematics.org>
  - Royal Horticultural Society plant finder database <http://apps.rhs.org.uk/rhsplantfinder>
3. The Garden Club of America expects all exhibitors to be aware of the need to promote conservation of endangered and threatened plants. Plants collected in the wild and listed by the Washington Natural Heritage Program may not be exhibited in any flower show sponsored by a GCA club. Cultivated plant material listed by Washington's Natural Heritage Program may be exhibited if accompanied by a typed card stating that it has not been collected from the wild or that it was collected out-of-state and giving information concerning its cultural requirements and methods of propagation. Natural Heritage Program lists of endangered plant material will be available before and during the show from the division chairmen and are available online at <http://plants.usda.gov/threat.html>.
4. Plant material showing evidence of insects or disease must be removed immediately from the exhibition area. This rule will be enforced at any time during the show, whenever the problem is identified.
5. All entries in the Floral Design and Horticulture Divisions must include fresh and/or dried plant material. Fresh plant material must be in water or conditioned in such a way as to remain in pristine form while on exhibition. An entry not maintained in show condition may have its award removed. Entries in Photography are not required to include plant material unless specified.
6. Locally invasive plants, diseased plant material, artificial plant material, live animals (including fish), taxidermy, natural birds' nests, and protected sea life, are not permitted, <http://plants.usda.gov/java/noxiousDriver>.



## General Information

---

1. Entries are open to all GCA club members, including provisionals, and professionals in their disciplines. Exceptions are listed in the schedule.
2. Registration is required for all classes, with the exception of those in Horticulture Division II, Classes 1-20 and 27-28. Registration forms are provided at the back of the schedule. Classes will be filled in the order registration forms are received according to the postmark/fax/email date and time.
3. While The Garden Club of America, Seattle Garden Club, and the Bellevue Botanical Garden will exercise due caution in safeguarding exhibits, responsibility for damage, loss or personal injury cannot be assumed.
4. Any clarification or change in the rules, as originally stated in the schedule, shall be communicated promptly in writing by the division chairman to all exhibitors in the class and, at the show, to the judges and to the passing committee.
5. An entry card must accompany each entry. Entry cards will be available at the show and upon request from the registration or division chairmen, in advance of the show. Information required on the entry card must be completed in black waterproof medium.
6. The passing committee must pass each entry before an exhibitor may leave the show area. The passing committee reserves the right to refuse any entry that does not conform to the rules of the schedule. The exhibitor has the option of correcting the entry, if time permits. If not corrected, the entry cannot be judged, but may remain in place, marked "For Exhibit Only" with a brief, constructively worded statement explaining why it was not judged. The judges may not disqualify any entry passed by the passing committee unless evidence of insect infestation or disease is identified.
7. Once an entry is passed, the exhibitor(s) must immediately leave the show floor. The only exception will be flower show committee members who have entered and been passed according to the timetable. A passed entry may not be touched again by the exhibitor until after judging and then only to carry out necessary maintenance.
8. Only participating judges and clerks will be allowed on the show floor during judging. Flower Show Chairmen and division chairmen should remain nearby but off the show until needed.
9. All containers and accessories must be inconspicuously labeled with the exhibitor's name.
10. A novice is an individual exhibitor who has not won a first place ribbon or a GCA Special Award, in the division entered at a GCA Flower Show, GCA Major Flower Show or Sanctioned Non GCA Major Flower Show. An exhibitor winning a blue ribbon in a GCA Flower Show is still considered a novice in a GCA Major Flower Show or in a Sanctioned Non GCA Major Flower Show or in another division of any flower show. In addition, an exhibitor who has won a blue ribbon or Special Award in a GCA Major Flower Show or Sanctioned Non GCA Major Flower Show is no longer a novice in any level of GCA Flower Shows in the division won. Only individual novice exhibitors are eligible to receive the Sandra Baylor Novice Floral Design Award.
11. A statement of intent is optional and must be submitted at the time of passing. The statement must be no more than 25 words, typed or printed in waterproof medium on a 4"x 6" white, unlined card.
12. All exhibits must remain in place and in show condition until fifteen minutes following the closing time of the show.

## Division I: Floral Design Guidelines

---

1. Please carefully read and follow the GCA Rules, General Information and Timetable for Exhibitors.
2. Floral design registration opens to The Seattle Garden Club members at 8:00 am PST on January 12, 2015; Zone XII Club members at 8:00 am PST on February 9, 2015; and all other GCA members at 8:00am PST on February 23, 2015. The deadline for registration is extended to May 1st, 2015. Entries will be accepted in order of registration by Floral Design Registrar, Sue Ashmun, at [susan@ashmun.com](mailto:susan@ashmun.com). Exhibitors will be notified whether or not they are accepted at the time of registration.
3. An exhibitor is permitted only one entry per class, but may enter more than one class. The exhibitor(s) under whose name(s) the entry has been registered must create and complete the design. All participants must be listed. Only listed exhibitors and show personnel may be on the show floor at the time of entry.
4. If forced to withdraw, an exhibitor must notify the registration chairman and class consultant, and find a substitute unless there is a waiting list for the class.
5. Mechanics should not be visible unless they are an integral part of the design.
6. Designs may be executed off-site and brought to the show completed.
7. Anything not prohibited in the GCA Rules, Floral Design Division Guidelines, or individual class descriptions is permitted.
8. Although permitted, the use of cut fruits and vegetables is discouraged and should be undertaken only with proper treatment to prevent spoilage and insect contamination.
9. Judging will be based on the principles of design: balance, contrast, dominance, proportion, rhythm and scale; and the elements of design: light, space, line, form, color, texture, pattern and size. Creativity is important, as are distinction, conformance to and interpretation of the class and schedule.
10. Accessories are permitted, unless otherwise stated in the class description.

11. Pertinent containers required for Class 4 and Class 5 will be available from the division chairman.
12. Questions regarding class requirements may be directed to the class consultant and/or division chairman.
13. Pedestals may not be moved, draped or enlarged.
14. A parallel design is one in which the plant material and other components are placed in strongly parallel groupings with open space between, which may be vertical, horizontal or diagonal. Additional components may be placed at any angle at the base as connectives. Multiple containers may be used, but design must appear as a single unit.
15. A miniature arrangement is a diminutive arrangement in which all components are no more than 5" in height.
16. An underwater design is a contemporary design style where all or part of the design must be visible under water.
17. The invitational challenge class is one where the design is completed on-site and within a specific timeframe.
18. The Point Scoring System may be used at the discretion of the coordinating judge and panel.

### **Class 1      Bridges to Adventure      6 entries**

A parallel design to be staged on a black pedestal 42" H x 22" square. The design may not exceed 12" from either side (right-left) and 6" from the front. No height restrictions. Viewed from 3 sides.

### **Class 2      Northwest Rocks      6 entries**

A miniature design incorporating a rock in the manner of an alpine meadow. Staged on a 6" clear plexi base and placed on a plank 52" above the floor. Viewed from the front. The base and plank will be provided to exhibitors at the show; color and specific information will be shared in advance by the Class Consultant.

### **Class 3      Sounds, Lakes and Rivers, Oh My      6 entries**

An underwater design, staged in a lighted, black niche with the interior measurements of 30" H x 20" W x 20" D. The base height of the niche is 42" from the floor. Exhibitor may provide a removable liner, but the surface of the niche may not be damaged. Viewed from the front.

## Division II: Horticulture Guidelines

---

1. Please carefully read and follow the GCA Rules, General Information and Timetable for Exhibitors.
2. Horticulture registration opens to SGC members for Classes 21-26 on October 6, 2014; Zone XII Club members at 8:00 am PST on February 9, 2015; and all other GCA members at 8:00am PST on February 23, 2015. Class 24 is open to all GCA members on November 1, 2014. The deadline for registration is March 30, 2015. Entries will be accepted in order of registration by Hort Registrar, Catherine Allan, at [jardinsroyaux@gmail.com](mailto:jardinsroyaux@gmail.com). Exhibitors will be notified whether or not they are accepted at the time of registration.
3. Entries must have been owned and grown by the exhibitor for a minimum of three months, unless otherwise stated in the schedule. Entries eligible for the **Catherine Beattie Medal** and/or the **Clarissa Willemsen Horticulture Propagation Award** must have been in the possession of the exhibitor for at least six months and will be identified on the entry card.
4. An exhibitor may submit one entry per class unless the class is not full. Unlimited entries are allowed for Cut Specimens, Class 1-20 and Par, Class 27-28. Where more than one entry is entered, each must be a different species or cultivar.
5. All entries propagated by the exhibitor must be so identified with the method and relevant date(s) of propagation on the entry card.
6. Mats, stands, saucers, stakes, ties, etc. are allowed.
7. Classes may be subdivided and entries moved and/or reclassified at the discretion of the show committee and/or the judges.
8. Containers are measured at the diameter or the diagonal of the widest point on the inside of the rim at the soil line.
9. One key card (diagram or plant list) is required when multiple species or cultivars are exhibited in the same container and/or propagation information is applicable. Key card must be a 4" x 6", white, unlined card and completed in black waterproof medium. A 4" x 6" photograph with identifying numbers may be used.
10. Container-grown plants should be exhibited in containers that are clean and unobtrusive. Terracotta clay pots are preferred, except where otherwise stipulated. Disguised double potting and top dressing are permitted; top dressing must not float when watered. Moss (rooted and unrooted) allowed as top dressing. Saucers required where needed to prevent leakage.
11. The Committee will provide containers and wedging materials for all cut specimens.
12. The committee will water the exhibits if instructed to do so in writing. Notify the Horticulture Chairmen at time of entry with written instructions for watering.
13. All horticulture entries must be identified with correct botanical names.
14. Inquiries concerning the horticulture classes should be directed to the consultants or the Horticulture Chairmen.
15. Some classes have a recommended scale of points for judging as described in *The Garden Club of America Flower Show and Judging Guide*, July 2014 Edition. If no scale is listed, the following point system may be used:

Scale, balance & design	20
Suitability & compatibility of plant material	20
<u>Suitable key card</u>	<u>10</u>

16. If desired for staging purposes, the BACK of the exhibit for potted entries Classes 22 -23 and 27-28 may be indicated with a small black, permanent dot near the base.

**Classes 1 – 20      Down the Garden Path – Cut Specimens**  
**Pre-registration not required                      Unlimited Entries**

Traverse far and wide in the Pacific Northwest from woodland walks to river sloughs to mountain trails and take in the splendors of the region, but gardeners never take for granted the treasures to be found in their own planting beds.

One stem, spike or spray not to exceed 36” in length, measured from top of stem to lip of container. Any foliage must be attached to the stem.

- 16A Truss – Upright:** Flowers held erect
- 16B Truss – Lax:** Pedicels easily viewed

A spray is a flower head composed of multiple flowers and leaves emerging from a single stem.

- 17A Spray – Upright:** Flowers held erect
- 17B Spray – Lax:** Pedicels easily viewed

## Classes 21-24 These Roots are Made for Walking -- Rooted Plants Pre-registration required

Consider the ground beneath our feet and the passage of plant roots wending their way through the soil. Container-grown plants replicate the condition of the wider plant kingdom and provide access to the unseen structures that feed, support and give life to the unquestionable beauty of our green world.

### Class 21 Out of the Primordial Soup

Challenge Class: Survivors of the past, Sarracenia (Pitcher Plant) thrive by trapping and digesting insects and more. One of these carnivorous plants (21A, B or C) was distributed to SGC members in Fall, 2014. Exhibitors may add up to 3 additional species of bog plants. Multiples of any species are allowed. To be displayed in a specific terra cotta container 12" in diameter specified by SGC. To be viewed in the round. A 4" x 6" key card detailing the method of care and identifying the botanical and common names of the plants and their location in the container is required. Six-month ownership requirement.

**Class 22 A River Runs Through It****6 entries**

A collection of 3 or more culturally compatible plants, including at least one northwest native, planted in a miniature 12" x 3" birch bark canoe specified by SGC. A 4" x 6" key card identifying the botanical and common names of the plants and their location in the canoe is required. Six-month ownership requirement.

**Class 23 The Long & Winding Road****6 entries**

A single climbing plant trained on a wire or wooden frame of the exhibitor's choosing, not to exceed 18" in height, and rooted in a container no larger than 14" in diameter. Open to novice exhibitors only. Two-month ownership requirement.

**Class 27**      Owned and grown by exhibitor for a minimum of six months.

**Class 28**      Owned and grown by exhibitor for a minimum of two years.

## Division III: Photography Guidelines

---

1. Please carefully read and follow the GCA Rules, General Information and the Timetable for Exhibitors.
2. **Online registration only.** Registration opens to Seattle Garden Club members at 8:00 am (PST) on Monday, January 5, 2015. Registration opens to all GCA members on Monday, February 2, 2015. Please include name, address, telephone number and email address along with the class number and title of a first and second choice of classes. Email the registration information to Suzy Titcomb, [stitcomb2@comcast.net](mailto:stitcomb2@comcast.net). Registrations will be accepted in the order in which they are received. Exhibitors will be notified whether or not they are accepted at the time of registration. All registration closes on Monday, March 30, 2015.
3. Exhibitors may make only one entry in a class. If forced to withdraw, an exhibitor must notify the Photography Chairman and find a substitute unless there is a waiting list for the class.
4. Photographs that have won first place or a special award in a GCA or GCA Major Flower Show may not be entered in competition again. A photograph that was previously entered and did not place first may be entered again if the image is altered and newly printed. The same photograph may only be entered in one show at a time.
5. Each photograph must be the work of the exhibitor, under whose name it is registered. This would include any manipulation done to the image, such as enhancement for color or clarity, removal of any part of the image, combining images or distorting the original subject.
6. Each photograph must be accompanied by two copies of the official entry form. One form must be attached to the back of the photo indicating the TOP of the photo. The second form must accompany the photograph unattached. A title or statement of intent may be included on the entry form but it is not required. Identification of the plant material on the entry form is not required but encouraged whenever possible.
7. Photography entries are limited to subjects consistent with GCA interests, such as horticulture, floral design, gardens/landscapes, conservation and the environment, historic preservation, civic improvement and the natural world.
8. Photographs must be mounted on white mat board and over-matted with a single white mat. The overall dimension may not exceed 50". Glass and framing are not permitted. The exception is Class 2, a triptych, three separate prints to be presented as one product with an overall dimension not to exceed 68" (for example, matting could be 10x24 and the photos could be 8x6 allowing for matting between and on either side).
9. All photographs will be hung against a black background.
10. All entries will be passed by members of the photography judging program to verify that the class specifications have been met. If a photograph is not passed, the exhibitor will be notified and allowed, if time permits, to send a replacement.
11. While the Seattle Garden Club will exercise due caution in safeguarding exhibits, they cannot assume responsibility for damage, loss or personal injury.

12. Only the photography committee may reclassify an entry, but only with the permission of the exhibitor. The photography committee and the judges may subdivide a class.
13. If a photograph entry is to be returned, the exhibitor must provide a self-addressed return label, envelope, and postage (no USPS or Fed Ex labels) and packing material. Any award received will be noted on the comment card and the ribbon enclosed with the photo.
14. Photographs must be received between April 3rd and April 15, 2015. Receipt of your photograph will be acknowledged. Photographs should be sent to Juliet Romano, 614 34<sup>th</sup> Avenue East, Seattle, WA. 98112.

16. Suggested method for mailing entries: Use two 15" x 19" bubble wrap envelopes or a sufficiently sized box. Wrap mounted and matted photographs between two suitable pieces of foam core (this is very light) or non-bendable cardboard which will be re-used for return. Place wrapped photograph and the second envelope (folded) with a self-addressed return label and adequate postage inside the mailing envelope or box. Photograph will be returned only if self-addressed envelope with adequate postage is provided.

## Division IV: Conservation & Education Exhibit

---

The Seattle Garden Club Conservation Exhibit will display the journey of roof rainwater at the Bellevue Botanical Garden. The system is designed to both conserve water and divert excess storm water from the sewer system. Homeowners will learn how to implement these ideas on a smaller scale.

At the BBG, roof rainwater travels to a large underground storage tank. The filtered rainwater is then used to flush toilets. When long rainy periods exceed the storage tank holding capacity, the excess water is sent into an adjacent lovely and functional rain garden. This exhibit will explain how a rain garden is built to absorb excess storm water and help keep Puget Sound clean while at the same time enhancing the beauty of home gardens. This can be done at home, and funding may be available depending on location.

# GCA Flower Show Awards

---

## Division I, Floral Design

The **Dorothy Vietor Munger Award** may be awarded to members of Garden Club of America clubs in competitive Floral Design classes at a GCA Flower Show. It is offered in recognition of creative work of outstanding beauty using predominantly fresh plant material. The design must have placed first, second, or third. Challenge class entries are not eligible. The award is not a substitute for Best in Show and will be given at the discretion of the judges.

The **Harriet DeWaele Puckett Creativity Award** may be awarded to members of GCA clubs or non-members in recognition of a uniquely skillful and creative response to an imaginative schedule in Floral Design. It will be given for an innovative and interpretive entry, which, although it abides by the principles of good design, goes beyond traditional period arrangement to whatever art form the exhibitor(s) chooses. The design must have placed first, second, or third in the Floral Design Division of a GCA Flower Show. An entry in any challenge class is not eligible to receive this award. The award is not a substitute for Best in Show and will be given at the discretion of the judges.

The **Sandra Baylor Novice Floral Design Award** may be given at a GCA Flower Show to an exhibitor who is a member of a GCA club and who has never won first place, or a GCA Special Award in the Floral Design Division of a GCA Flower Show, GCA Major Flower Show or Sanctioned Non GCA Major Flower Show. It shall be awarded to an individual novice exhibitor for a unique and skillful response to the schedule. Novice entries placing first, second, or third in any competitive class, including challenge classes, are eligible for this award.

## Division II, Horticulture

The **Catherine Beattie Medal** is to be awarded for a horticulture entry distinguished by its vibrancy, prime condition, and perfection of grooming. The exhibitor must have owned and grown the exhibit for at least six months. The medal may be awarded for a single plant, collection of plants, container garden, or cut specimen, but only if there is an exhibit worthy of the honor. It may be awarded to members of GCA clubs only; individual, joint, and club entries are eligible. The award should not be considered as a substitute for Best in Show. The medal may not be awarded to the same exhibit more than once; however, offspring of a Beattie winner are eligible to receive the award.

The **Clarissa Willemsen Horticulture Propagation Award** is to be awarded for a horticulture entry distinguished by its prime condition, flawless grooming and difficulty of propagation. The entry must have been propagated and grown by the exhibitor for at least six months. This award may be given for a single rooted plant or a collection of rooted plants. The dates and method of propagation must be recorded on the entry card. The entry must have placed first, second, or third at a GCA Flower Show. The award may not be given to the same exhibit more than once.

The **Rosie Jones Horticulture Award** may be presented to a horticulture entry of exceptional visual appeal that reflects the spirit of growing with joy and enthusiasm and inspires others to propagate, grow, show and share horticulture. An exhibit that has been propagated by the exhibitor will be given special consideration but propagation is not a requirement. Perfection, while always desirable, is not a primary criterion. This award celebrates the ineffable joy inherent in the beauty and pursuit of horticulture.

## Division III, Photography

The **Photography Creativity Award** may be awarded at a GCA Flower Show to a member of a GCA club in recognition of creative and technical excellence in response to the theme of the schedule. The entry must have placed first, second, or third.

## Divisions II & III

The **GCA Novice Award** may be given at a GCA Flower Show in the Horticulture, Photography and Botanical Arts to an exhibitor who is a member of a GCA club and who has never won first place or a GCA Special Award in the division entered, of a GCA Flower Show, GCA Major Flower Show or Sanctioned Non GCA Major Flower Show. It shall be awarded to an individual novice exhibitor for an outstanding exhibit. Novice entries placing first, second, or third are eligible for this award.

## Division IV, Conservation and Education Exhibit

The **Ann Lyon Crammond Award** may be presented at a GCA Flower Show to an outstanding educational exhibit, which best educates the public about gardens. Any educational exhibit, which increases the appreciation of any aspect of plants, gardens, or landscape design, may be considered for this award. The award may be given to GCA club members, member clubs, non-members or other organizations.

The **Marion Thompson Fuller Brown Conservation Award** may be presented for an outstanding conservation exhibit at a GCA Flower Show. The award recognizes an exhibit of exceptional educational and visual merit, which increases knowledge and awareness of the environment. The exhibit should emphasize environmental concerns and may demonstrate conservation practices. Plant material may or may not be used and, when appropriate, must be clearly identified. Protected material may be included if such materials are identified as protected and not collected in the wild. The award may be given to Garden Club of America clubs, club members, non-members or other organizations.

## Overall

**Best in Show**, selected from among the first place winners, may be awarded in each division.

**Judges' Commendation(s)** may be given to an entry, class, section, special exhibit or other aspect of the show that is of exceptional merit.

**Award of Appreciation** may be given to thank an exhibitor or group for participation. The award may also be given to non-judged classes.

## Seattle Garden Club Awards

---

The **Martha Lindberg Isaacson Award**, Seattle Garden Club's Best in Show Award in Floral Design, may be selected from the blue ribbon winners for its distinction in one or more of the six principles of design: balance, contrast, dominance, proportion, rhythm, scale.

The **Virginia Merrill Bloedel Award**, Seattle Garden Club's Best in Show Award in Horticulture, may be selected from the blue ribbon winners for one or more distinctions in: originality in presentation, aesthetic appeal, good design or rarity and difficulty of cultivation.

The **Noreen Frink Photography Award**, Seattle Garden Club's Best in Show Award in Photography, may be selected from the blue ribbon winners for its distinction in one or more of the six principles of composition: balance, contrast, dominance, proportion, rhythm, scale.
